### MTP 2050 Progress

The Metropolitan Transportation Plan (MTP) is a strategic, long-term document guiding future transportation projects in the WAMPO region. By federal mandate, Metropolitan Planning Organizations must involve the public throughout the planning process. The MTP 2050 must be completed by May 2025. Staff conducted a first round of public engagement and are preparing for the call for projects and the second round of public comment.

### **Round 1 Public Engagement Results**

Round 1 of public engagement for the Metropolitan Transportation Plan 2050 ended on July 31<sup>st</sup> and the results are now available. The WAMPO team spent over 200 hours at pop-up events, interviews, listening sessions, and more to get the public involved in the planning process. Below are the results of the surveys that were collected and a compilation of summaries from listening sessions with key interest groups.

Phase 2 of public engagement for MTP 2050 will begin in December of 2023.

### **MTP/TIP Call for Projects**

On September 15, 2023, WAMPO will open a combined Call for Projects for the long-range Metropolitan Transportation Plan 2050 (MTP 2050) and the short-range FFY2025-FFY2028 Transportation Improvement Program (TIP). Because there will be a single Call for Projects for both of these planning documents, jurisdictions that need to add or modify a project in both of them will only need to submit a single application (any project that will use federal funding or be regionally significant must appear in the TIP, which must be consistent with the MTP). Jurisdictions will be asked to submit their applications by January 5, 2024. The FFY2025-FFY2028 TIP is due to be approved by the WAMPO Transportation Policy Body (TPB) in August 2024 or earlier. MTP 2050 is due to be approved by the TPB in May 2025 or earlier.


### **Round 2 Public Engagement**

Round 2 of Public Engagement will focus on alternate scenarios preferences and performance measures. To capture the public's feedback, WAMPO staff will distribute another survey that will be open from December 2023 through February 2024. The survey will provide alternate scenarios and ask for respondents' preferences. This input will be used to develop a preferred scenario in the spring of 2024.



#### **Planning Timeline**

The plan will be completed in May 2025. However, there are many steps between now and then. The timeline graphic below shows the high-level deliverables.



# **Transportation Planning Updates**

#### **Electric Vehicle Network Plan**

The public engagement phase for the Electric Vehicle Network Plan has ended, with the survey closing on August 31st. We'll soon have access to the survey results. Here's what's coming next:

1. **Presenting Results:** We'll analyze the survey feedback and create a report. This report will be shown to the steering committee in charge of the plan. It'll highlight what people shared, helping everyone understand public opinions.

2. **Finding Policies:** Using the survey insights, we'll figure out suitable rules and agreements. These will match what the public wants. These rules will guide how the plan gets carried out.

3. **Updating Vision:** The survey could lead us to rethink the plan's main idea and goals. We'll make adjustments to make sure the plan fits what people care about now.

4. **Keep Working on the Plan:** With the survey's insights and new policies in mind, we'll keep building the Electric Vehicle Networking Plan. We'll make sure it includes the new ideas and stays on track to meet its goals.

The goal is to make sure the plan respects what the community wants, and that the electric vehicle network gets better for everyone. This plan will be completed in late 2023/early 2024. Visit <u>www.wampo.org/electric-vehicles</u> to follow the planning process.

#### **Comprehensive Safety Action Plan Updates**

WAMPO is in the process of developing a Comprehensive Safety Action Plan (CSAP). Upon its expected adoption in late summer/fall 2023, the WAMPO region will be eligible for U.S. Department of Transportation (USDOT) discretionary Safe Streets and Roads for All (SS4A) Implementation grants. Additional information about the Comprehensive Safety Action Planning process is available at <u>www.wampo.org/safety</u>.

The SS4A Notice of Funding Opportunity (NOFO) for this year was published earlier than expected, with the result that grant applications were due on July 10th, 2023, prior to the expected adoption of the WAMPO CSAP, meaning the WAMPO region will not be able to apply for any Implementation grants during this round of funding. Instead, WAMPO staff and consultants put together a Planning and Demonstration grant application, which was submitted on June 30, 2023. WAMPO intends to then apply for an Implementation grant in 2024 or 2025.

The draft Comprehensive Safety Action Plan (CSAP) Implementation Plan was discussed at the August 2nd Safety and Health Committee meeting. The Transportation Safety Technical Advisors (TSTA) will discuss the draft Implementation Plan on August 29. There will be a 30-day public comment period in August/September. Following that, the CSAP will be brought before the TPB for approval consideration. The consultants will soon begin working on Safe Streets Visualization and developing a Vision Zero Toolkit.

### **Safe Routes to School**

The Federal government makes funding available to local governments and school districts to make it safer for children to walk, roll, or bicycle to and from school. This is done through the so-called "6 Es" of Safe Routes to School (SRTS): Engagement, Equity, Engineering, Encouragement, Education, and Evaluation, which encompass both infrastructure improvements and behavior-focused initiatives. For SRTS activities to qualify for Federal funding, they must be part of the implementation of an SRTS plan, with cooperation between local governments and school districts. For that reason, WAMPO has secured \$200,000 of Transportation Alternatives (TA) funding in FFY2024 for




SRTS planning in the region. Although the exact outlines of this planning effort are still under discussion, the intent is to help interested local governments and school districts establish SRTS plans and thereby qualify for Federal funding for activities described in those plans. As part of this effort, WAMPO is considering an update to the Regional Safe Routes to School Plan, which was last updated in 2008 by WAMPO and the Safe Kids Wichita Area Coalition.

### **Coordinated Public Transit-Human Services Transportation Plan**

WAMPO is currently in the process of updating its Coordinated Public Transit - Human Services Transportation Plan. This plan focuses on the transportation needs of older adults, people with disabilities, and low-income households. The following graphic depicts the plan update process:

### WAMPO Suballocated Projects for 2023-2024

WAMPO awarded Suballocated Federal funding to the following projects in Federal Fiscal Year (FFY) 2023:

- Wichita Transit: "Wichita Transit Network Redesign Plan"
- Wichita Public Works: "West St., Harry to Pawnee"
- Valley Center: "Meridian, from Ford (77th St. N.) to Seward (69th St. N.) and Main to 5th (85th St. N.)"
- Sedgwick County: "Zoo Boulevard Bridge over M.S. Mitch Mitchell Floodway"

In the WAMPO Transportation Improvement Program (TIP), the following projects are programmed to receive Suballocated funding in FFY2024 (projects may be added to or removed from this list during FFY2024, which starts October 1, 2023):

- Wichita Public Works: "West St., I-235-MacArthur"
- Wichita Public Works: "Douglas, Seneca to Meridian" (may be moved to FFY2025)



- Haysville: "Seneca & 63rd Street Bike Ped Pathway"
- Derby: "Nelson Drive Realignment"
- Kechi: "Oliver and Kechi Rd. Intersection"
- Kansas Department of Transportation (KDOT): "WICHway Video Wall"
- WAMPO: "Safe Routes to School Planning Assistance"

### North Amidon Project Update – Nick

Since Fall 2022, the Amidon Avenue bridge across the Arkansas River in north Wichita has been closed for reconstruction (the recommended detour is to follow 13<sup>th</sup> St./21<sup>st</sup> St. to West St.). According to City of Wichita Public Works staff, a majority of the bridge concrete work is completed, and the adjacent pavement and remaining bridge items are to be completed within the next few months. At this time, crews are ahead of schedule and the City anticipates opening for traffic by Thanksgiving 2023. Recent pictures are included below.





### **Certification Review Results**

WAMPO completed its quadrennial Certification Review with the Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA) on May 10-12. 2023. The results of that Certification Review were positive and did not include any required corrective actions. Three commendations were made.

- 1. WAMPO is commended for its use of innovative public involvement strategies to engage the public, particularly its efforts to have a presence at community events.
- 2. WAMPO and Wichita Transit are commended for the integration of transit participation into the MPO planning process through transit agency representation on most MPO committees.
- 3. WAMPO's creation of MPO subject-specific committees as a result of strong public interest is a best practice.

# KAMPO Update

On Monday, August 21, 2023, we hosted the Kansas Association of Metropolitan Planning Organizations (KAMPO) gathering. The event was attended by a total of 30 participants, including representatives from KDOT, Flint Hills MPO, Lawrence-Douglas MPO, Mid-America Regional Council, St. Joseph Area Transportation Study Organization, Federal Highway Administration, Urban Corridor CTD Mobility Manager, CTD #9 Mobility Manager, and Sedgwick County Health Department. The meeting commenced with an overview of MPO highlights, focusing on core documents and special projects. Updates were also provided by KDOT as well as FHWA.

The primary agenda of the meeting revolved around several key topics. These included discussions on the Comprehensive Safety Action Planning Process, dialogue about Bicycle and Pedestrian Data Collection, and considerations related to Electric Vehicle Planning. Additionally, the meeting covered subjects such as Food Access and Transportation Planning, Safe Routes to School initiatives, Funding Discussions, and collaborative efforts for Regional Transit.

It was also noted during the meeting that the next KAMPO event will be organized by St. Joseph Area Transportation Study Organization, with the exact date yet to be determined.
