i. Overview

Chad Parasa gave an overview of the upcoming presentations, including an action item on TIP Amendment #4.

ii. HIP (Highway Infrastructure Program) federal funds Call for Projects

\$683,064 of HIP funds have been allocated specifically for the WAMPO region in FFY2020, which must be obligated by September 30th, 2023 and spent by September 30th, 2028. An additional \$556,717 has been allocated specifically for the WAMPO region for FFY2021, which must be obligated by September 30th, 2024 and spent by September 30th, 2029. The total funds available is \$1,239,781. These funds may be used on separate or the same projects and are available immediately for obligation. WAMPO is currently accepting applications for projects already in the TIP with costs greater than what already-

authorized funds cover, and projects in the MTP that did not make it into the TIP. The deadline for applications is August 31st, 2021.

iii. Bike Ped Counts-September 23rd & 25th

Kathryn Chambers gave a call to action for volunteers for WAMPO's upcoming annual bike and pedestrian count.

4. New Business

A. Action: 2021-2024 TIP (Transportation Improvement Program) Amendment #4

Amendment #4 is composed of five administrative adjustments and two new projects that require formal action. The public comment period for this amendment is scheduled to end July 30th, 2021. All of the projects are consistent with the current MTP and are fiscally constrained.
