### C. Director's Report

### i. FFY2023 TIP Projects Status Update

Nick Flanders, WAMPO, provided a TIP project status update. The WAMPO TIP Policy includes a Reasonable Progress Policy, under which projects receiving WAMPO-suballocated funding in the current FFY or that received it in a past FFY but are not completed are to have bimonthly progress reports to the TAC/TPB.

# ii. Comprehensive Safety Action Plan Update and Safe Streets and Roads for All Grant Application

WAMPO and a consultant team are developing a Comprehensive Safety Action Plan (CSAP) for the region. Ashley Bryers, WAMPO, provided an update about the CSAP status and the application for Safe Streets and Roads for All (SS4A) grant funding that would support that effort. The SS4A grant application was due on July 10, 2023. WAMPO staff submitted the application on June 30. Ms. Bryers reported that WAMPO requested funding for two buckets of projects that fall under the "Planning and Demonstration Grant." Those projects include Pilot Behavioral Strategies and Before and After Studies projects. The state of Kansas will provide a 15% local match, meaning local jurisdictions would only need to pay a 5% match if awarded a grant. Erin Grushon, Burgess and Niple shared that they should receive updates about the grant application near the end of the year.

### iii. MTP 2050 Public Engagement Update

Ms. Bryers said that for the first round of public engagement for Metropolitan Transportation Plan 2050 (MTP 2050), a survey about the current state of transportation and the future of transportation needs in the WAMPO region is available at <a href="https://www.wampo.org/mtp2050">www.wampo.org/mtp2050</a>. Ms. Bryers reported that WAMPO staff are attending public meetings and holding pop-up events in May-July 2023 to promote this survey and gather responses. In addition to collecting input through the survey, nine stakeholder listening

#### i. Video Creation Services Contract

Enter into a contract with Method Productions to provide video creation services through December 31, 2023, for not to exceed \$49,604.66. The number of videos to be produced in 2024 and 2025 will be negotiated prior to the start of each of those years, with a budget for each year not exceeding \$50,000.

### ii. Regional Transit Implementation Plan Contract

Enter into a contract with SRF Consulting Group with Nelson Nygaard and Shockey Consulting to develop a Regional Transit Implementation Plan through December 31, 2024, for not to exceed \$149,922.11. Consultants will collaborate with the United Community Transit Coalition (UCTC) and engage with transit agencies and decision-makers to establish a coordinated regional transit network.

#### 3. Public Comments

Jayne Byrnes, a Wichita resident, expressed concerns about the high pedestrian fatality count caused by car crashes. She reported that this fatality rate is trending nationally and locally. Ms. Byrnes urged the TPB to consider the safety of pedestrians and bicycle riders. She advocated for the board to include diverse stakeholders, such as social workers, who will select projects to fund in upcoming years that prioritize the safety of non-drivers.

#### 4. Action

### A. Project Selection Committee 6/12/2023 Recommendations

Ms. Bryers reported that the WAMPO Project Selection Committee (PSC) met on June 12, 2023. They made project-funding recommendations that were submitted to the TPB for final action. First, in response to submissions for a special Call for Projects (March 1-May 1, 2023), they recommended five (5) specific projects to which to award approximately \$3.9 million (cumulatively) of Carbon Reduction Program (CRP) in FFY2024-FFY2025. Then, they recommended permitting \$131,559 of unused CRRSAA funding from the WAMPO project "WAMPO Travel Demand Model Update" to be placed on a "phase 2" TDM-update project, provided that recent Federal legislative actions allow it. The primary goal of the CRP is to reduce CO<sub>2</sub> emissions from transportation. Six projects were submitted for funding. Peter Mohr, WAMPO, explained the Project Selection Committee's recommendations for funding and discussed the process for determining how to obligate remaining CRRSAA funds. Contingent on state and federal rules allowing it, WAMPO staff proposed, and the PSC recommended that the remaining funds be allowed to be moved to the FFY2024 project "WAMPO Travel Demand Model Update Phase 2".

#### **Discussion:**

David Dennis asked why the project "Maple Street Pathway" was only considered for \$39,827. Mr. Mohr explained that the funding brings the project up to 80% federal funding, as it already had other federal funding.

Dan Woydziak further explained that several projects were funded short of 80%. The group will later meet to reach 80% funding if additional funding becomes available.

Mr. Dennis then asked whether the electric vehicle (EV) chargers at the Multimodal Facility (MMF) were for busses or passenger vehicles and followed up with a question about how the location for the chargers was determined. Paul Gunzelman, City of Wichita, reported that the project scope has always included installing electric vehicle charging stations in the multimodal facility.

<sup>\*\*\$1,000,000</sup> is the amount of funding that was requested; lead-agency staff have vouched that, with that amount of funding, the project will not exceed 80% federal funding (revised project cost estimate unavailable at this time). This will be a separate TIP project from the existing project "Delano Transit Center" (40-570), covering the non-transit aspects of the planned facility (e.g., electric-vehicle charging stations and bicycle storage).

<sup>\*\*\*</sup>Amount cannot be known for certain until the FFY2024 WAMPO suballocation of CRP funds is announced. Current estimate is \$2,234,019.

Mr. Dennis then expressed concern about the location of the electric vehicle charging stations due to the seemingly low demand for EV drivers to charge their vehicles in that area. As such, he expressed hesitation about allocating funding to this project.

James Wagner, Mr. Woydziak, and Ms. Bryers further explained the project's scope and factors that were considered for funding the multimodal facility. The Multimodal Facility already was going to include EV charging station, regardless of whether it received CRP funds, and no other EV-charging locations were submitted for the funding.

Gary Janzen, City of Wichita, reported that the city has a \$15 million grant from the Federal Transit Administration (FTA). The project included electric vehicle chargers in the MMF. The project will build the infrastructure for EV charging stations, and additional funding will be allocated to the project in the future. This project scope always included charging stations as part of the FTA project.

The TPB discussed whether it was feasible to defer this action for one month and submit it to the TAC to review it again. Ms. Bryers reported that the projects must be included in the TIP by November, so the projects should be approved by October, as the funding will expire soon.

Mr. Woydziak reported that if the plan changes and the board decides to build the EV charging stations elsewhere, they may take the funding. It is unlikely that the board will get additional information to improve the plan or determine whether a new location for the project is better.

#### 5. Discussion/Updates

### A. Projects Not Yet Obligated

Mr. Flanders provided an overview of WAMPO's Reasonable Progress Policy, which requires sponsors of projects programmed to receive WAMPO-suballocated funding in the current FFY that are not yet obligated to present their statuses to the TAC at their first meeting after May 31 and to the TPB at their first meeting after that. The FFY2023 projects affected by this requirement include one Haysville project, one Wichita project, and one Valley Center project.

Will Black, City of Haysville, explained the status of the project "Seneca & 63rd Street Bike Ped Pathway." The project will obligate in October and let in November.

James Wagner, City of Wichita, explained the status of the project "West St., Harry to Pawnee" and provided a projected schedule.

Valley Center will provide an update on the project "Meridian, from Ford (77th St. N.) to Seward (69th St. N.) and Main to 5th (85th St. N.)" at the next TPB meeting.

**Discussion:** Jim Benage asked if the City of Wichita plan included rebuilding intersection K-42. Mr. Wagner confirmed that the project does include K-42.

### B. Fans With A Plan and KDOT Law Enforcement Liaisons

Brian Turner, Wichita Sports Commission, and Troy Wells and Daniel Kiser, KDOT Law Enforcement Liaisons, explained the coalition's efforts to improve driver behavioral safety in the region.

Mr. Turner provided an overview of the partnership with KDOT to promote regional driver behavioral safety. The aim of the project is to develop a marketing campaign that drives awareness about the importance of planning ahead for outings to avoid driving under the influence.

Mr. Wells and Mr. Kiser provided updates about Kansas driver safety statistics and upcoming marketing campaigns that promote driver behavioral safety.

#### **C. 5310 Awards**

Dora Gallo, WAMPO, explained the Section 5310 grant awards process. The Section 5310 grant program provides federal funding to enhance transportation options for seniors and individuals with disabilities in the United States. It supports services beyond traditional public transportation and aims to improve access to essential services and community activities. Funding can be used for vehicles, operational costs, training, and transportation plans. Wichita Transit manages the Section 5310 grant program in the region, with funding available this year from 2021 and 2022 allocations totaling \$1,077,144. WAMPO led the call for projects and grant selection process.

# **Executive Summary**

WAMPO is developing an Electric Vehicle Plan for the region. The plan-development process is currently in the public engagement phase, for which a public survey has been launched that will help WAMPO understand needs and identify potential goals and strategies for this plan.

# **Background**

The Electric Vehicle Plan will outline the first steps the region can take to support and encourage electric-vehicle (EV) adoption, deliver a comprehensive course of action to provide EV charging infrastructure, and remove barriers to further efficient and effective EV adoption in the WAMPO region. This plan will serve as a starting point for private and public entities to grow more familiar with the opportunities and challenges related to electric vehicles, charging infrastructure, and the adoption thereof.

The Electric Vehicle Plan will support the Metropolitan Transportation Plan 2050 (MTP 2050) and the Charge Up Kansas National Electric Vehicle Infrastructure (NEVI) Plan by advancing the use of EVs to improve air quality and foster economic development. WAMPO has an opportunity to adapt to emerging technologies by closing EV-charging infrastructure gaps and removing barriers to EV adoption.

### Survey

As part of the plan development, WAMPO has launched a public survey. The survey responses will help WAMPO understand needs and identify potential goals and strategies for this plan. The survey is available in English, Spanish, and Vietnamese at <a href="https://www.wampo.org/electric-vehicles">www.wampo.org/electric-vehicles</a>. The survey will close on August 31, 2023.

# **Executive Summary**

WAMPO is currently in the process of updating its Intelligent Transportation Systems (ITS) plan. ITS projects funded through the highway trust fund are required to conform to the National ITS Architecture and applicable standards. These federal regulations and policies aim to promote the deployment of integrated regional ITS systems.

## **Background**

The purpose of developing a regional Intelligent Transportation Systems (ITS) architecture is to illustrate and document regional integration so that planning and deployment can take place in an organized and coordinated fashion. Typically, a region contains multiple transportation agencies and jurisdictions. Regional integration allows for the sharing of information and coordination of activities among regional transportation systems to operate efficiently and effectively. ITS projects funded through the highway trust fund are required to conform to the National ITS Architecture and applicable standards. The intention of these federal regulations and policies is to foster the deployment of integrated regional ITS systems.

The current WAMPO ITS plan was last updated in November 2006 and included three volumes: Volume 1, Wichita Architecture; Volume 2, Implementation Plan; and Volume 3, Communications Plan. WAMPO staff are in the process of updating this plan and will continue to do so during the remainder of 2023 and into 2024.

# **Executive Summary**

The Safe Routes to School (SRTS) Program aims to make walking and biking to school safer for students in the United States. Established in 2005 under SAFETEA-LU, its goals are to promote safety, active transportation, and community engagement while reducing traffic congestion. WAMPO is actively planning and identifying stakeholders for successful program implementation, including infrastructure improvements, educational programs, and encouragement activities. The focus is on creating safer environments for students and promoting healthier lifestyles.

### **Background**

The Safe Routes to School (SRTS) Program is a national initiative in the United States that aims to improve the safety and accessibility of walking and bicycle routes for students traveling to and from school. The program was established in 2005 under the federal transportation bill known as the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU). The primary goals of the SRTS are to promote safety, encourage active transportation, reduce traffic congestion, and create a sense of community. The Safe Routes to School Program is typically implemented at the state and local levels, with federal funding allocated to individual states for distribution.

## **WAMPO's SRTS Program**

WAMPO will be embarking on an extensive planning process to ensure the successful implementation of the Safe Routes to School Program.

Some of the key components that WAMPO needs to consider:

- » Infrastructure Improvements
- » Educational Programs
- » Encouragement Activities
- » Enforcement and Evaluation

By implementing the Safe Routes to School Program, communities can create safer environments for students, encourage healthier lifestyles, and contribute to the overall well-being of children and their communities.

# **Executive Summary**

In mid-July 2023, KDOT staff informed WAMPO staff of an opportunity to add up to \$5,000,000 of federal funding to FFY2023 projects. On July 25, 2023, the WAMPO Project Selection Committee (PSC) met to decide how to use these funds in the limited time available before the end of FFY2023. Due to the short timeframe, not many projects could absorb the available funds. The PSC selected three projects to recommend for additional FFY2023 funding through TIP administrative adjustments.

### **Recent Funding Opportunity**

On July 14, 2023, Mark Bechtel (FTA) informed Mike Tann (Wichita Transit) of an opportunity for local projects to absorb federal funds reallocated to KDOT in August 2023 for FHWA obligation or FTA transfer before the end of FFY2023. Then, on July 20, 2023, Allison Smith (KDOT) confirmed that up to \$5,000,000 of STBG and/or CMAQ and/or TA funds could be put towards WAMPO local projects if a TIP administrative adjustment is completed quickly enough. This was possible because WAMPO had accumulated unused portions of its federal funding allocations over previous years, since KDOT usually does not allow a year's entire allocation to be used that year, instead restricting MPOs to an "obligation limitation" (usually about 90%). On July 25, 2023, the WAMPO Project Selection Committee (PSC) met to decide how to use these funds in the limited time available before the end of FFY2023. Due to the short timeframe, not many projects could absorb the available funds. The PSC selected three projects (see below) to recommend additional FFY2023 funding through TIP administrative adjustments.

# Agenda Item 4A: Action FFY2023-FFY2026 Transportation Improvement Program Amendment #4

### **Executive Summary**

The TPB is asked to take action on proposed Amendment #4 to the WAMPO FFY2023-FFY2026 Transportation Improvement Program (TIP). Amendment #4 is a regularly scheduled TIP amendment and would maintain the fiscal constraint of the FFY2023-FFY2026 TIP. The Public Comment period for Amendment #4 opened on June 30, 2023, and ran through July 14, 2023. No public comments have been received to date. One new project and one adjusted project were added during the Public Comment period on July 11, 2023. Following the close of the Public Comment period on July 25, an additional administrative adjustment that does not require TAC or TPB approval were performed on a project. The TAC recommended approving TIP Amendment #4 at their July 24<sup>th</sup> meeting.

### **Background**

Amendment #4 to the WAMPO FFY2023-FFY2026 Transportation Improvement Program (TIP) is a regularly scheduled amendment. It is the fourth scheduled amendment for this TIP, adding nine (9) new projects (one of which was added during the Public Comment period on July 11, 2023) and **modifying seven (7) projects**. The below-linked Amendment #4 summary also provides notice of administrative adjustments to an additional sixteen (16) projects (one of which was added during the Amendment #4 Public Comment period on July 11, 2023, and one of which was performed following the close of the Public Comment period, on July 25, 2023), which do not require approval by the TAC or TPB. The Public Comment period for Amendment #4 opened on June 30, 2023, and ran through July 14, 2023. On July 11, 2023, at the request of the City of Wichita staff, one new project was added to Amendment 4, titled "Reconnecting Communities Study: 21st Street Corridor from I-135 to Broadway, Wichita, KS". Also, on July 11, 2023, at the request of City of Haysville staff, an administrative adjustment was added to push back the project "Seneca & 63rd Street Bike Ped Pathway" from FFY2023 to FFY2024 to accommodate a new anticipated obligation date. On July 25, 2023, on the advice of the WAMPO Project Selection Committee (PSC), an administrative adjustment was performed on the cost and funding sources of the Wichita Transit Project "Delano Transit Center". To date, no other public comments have been received. The FFY2023-FFY2026 TIP took effect on October 1, 2022, and may be found at www.wampo.org/transportation-improvement-program. The TPB is now asked to vote on the proposed project additions/modifications.

## **Fiscal Considerations**

Federal regulations require that the TIP be "fiscally constrained," meaning that there are enough projected revenues to cover the costs of the projects listed in the TIP. After accounting for the proposed changes (see table at top of next page), the TIP is fiscally constrained for the period FFY2023-FFY2026.

» If the amendment is approved, it will then be sent to the Kansas Department of Transportation (KDOT) to be included in the State Transportation Improvement Program (STIP) for review and consideration by the Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA). Federal approval of the STIP amendment is expected in September 2023.

# **Executive Summary**

MPOs are required to set performance measures for roadway safety (PM1), pavement and bridge condition (PM2), system performance, and freight movement (PM3), transit asset management (TAM), and transit safety. It is proposed that WAMPO support Wichita Transit's 2023 Transit Safety Targets that were set on December 29, 2022, by Wichita Transit staff. The targets are the same as the 2022 targets because there have not been any more changes to their routes, ridership, or equipment. The TAC recommended approval of the 2023 Transit Safety Targets for the WAMPO region at their July 24<sup>th</sup> meeting.

### **Background**

The Federal Highway Administration (FHWA) and Federal Transit Administration (FTA) jointly issued a Planning Rule that establishes various performance measures to assess roadway safety (PM1), pavement and bridge condition (PM2), system performance, and freight movement (PM3), transit asset management (TAM), and transit safety. State Departments of Transportation (DOTs) and Metropolitan Planning Organizations (MPOs) are required to set targets for the various federal performance measures.

### **Transit Safety Targets**

Under the FTA's Public Transportation Agency Safety Plan (PTASP) rule, applicable transit agencies are required to develop safety plans that define how those agencies will implement Safety Management Systems (SMSs). These plans are required to include targets for performance measures defined in the National Public Transportation Safety Plan, which relate to fatalities, injuries, safety events, and system reliability. MPOs are federally required to set performance targets for these transit safety performance measures for their regions, in coordination with transit agencies and state governments. These requirements acknowledge the collaborative relationships needed to manage safety risks in transit systems.

Wichita Transit set Transit Safety Targets in 2022. They are utilizing the same targets in 2023 because there have not been any major changes to their routes, ridership, or equipment. These targets were selected by Transit staff on December 29, 2022.

### **Executive Summary**

WAMPO's Reasonable Progress Policy requires sponsors of projects programmed to receive WAMPO-suballocated funding in the current FFY that are not yet obligated to present their statuses to the TAC at their first meeting after May 31 and to the TPB at their first meeting after that. In FFY2023, one Haysville project, one Wichita project, and one Valley Center project fall into this category. The Valley Center project will be presented at this meeting.

### **Background**

Page 23 of the WAMPO Transportation Improvement Program (TIP) Policy (Appendix I of the FFY2023-FFY2026 TIP, <a href="https://bit.ly/Appendix1-TIP-Program-Policy">https://bit.ly/Appendix1-TIP-Program-Policy</a>) establishes a Reasonable Progress Policy. This Reasonable Progress Policy was revised by the TPB on April 11, 2023. One of the changes made on that occasion was to establish that:

"At the TAC meeting following May 31st and the TPB meeting following that TAC meeting, project sponsors with projects in the current FFY not obligated will be required to present their project's status, both verbally and in writing, and be available to answer questions from the TAC and TPB. On this occasion, they may also request additional time to obligate, if necessary."

There are three Federal Fiscal Year (FFY) 2023 projects that, as of June 2023, had not yet obligated their WAMPO-suballocated funds, meaning the sponsors of those projects are required to report on their statuses to the TAC and TPB both in writing and verbally:

- >> Haysville: "Seneca & 63rd Street Bike Ped Pathway"
- » Wichita: "West St., Harry to Pawnee"
- >> Valley Center: "Meridian, from Ford (77th St. N.) to Seward (69th St. N.) and Main to 5th (85th St. N.)"

All three project sponsors reported on these projects' statuses to the TAC on June 26, 2023. On July 11, 2023, Haysville and Wichita reported on their projects' statuses to the TPB, but Valley Center was unable to make the meeting. Now, Valley Center is providing its project status report to the TPB.

# **Executive Summary**

The 2024 Unified Planning Work Program (UPWP) is WAMPO's budget, describing the planning activities it will undertake throughout the year. A majority of staff time will be occupied by the development of the next Metropolitan Transportation Plan, MTP 2050; however, the UPWP describes other activities as well.

# **Background**

The Unified Planning Work Program (UPWP) describes how the federal planning funds allocated to WAMPO (in the form of Consolidated Planning Grant (CPG) funds) will be used and what planning activities WAMPO staff and consultants will undertake each year. The UPWP is developed by WAMPO staff with input from local governments, Wichita Transit, Kansas Department of Transportation (KDOT) staff, Federal Highway Administration (FHWA) staff, and Federal Transit Administration (FTA) staff. A new UPWP is produced each year. The UPWP needs to consider the Planning Emphasis Areas identified by the FHWA and FTA. Further, under the Bipartisan Infrastructure Law (BIL), passed in November 2021, at least 2.5% of planning funds need to be used on specified planning activities to increase safe and accessible options for multiple travel modes for people of all ages and abilities.

A UPWP needs to have the following components:

- **»** Planning work tasks for regional and metropolitan planning priorities and activities that address federal planning requirements.
- » Resulting products.
- » Responsible organizations.
- » Time frames.
- » Costs.
- >> Funding sources (FHWA, FTA, state, local).

After the 2024 UPWP is approved by the WAMPO Transportation Policy Body (TPB), it will be approved by FHWA and FTA, with KDOT providing oversight.

### **Core Documents**

WAMPO has five "core" documents, which need to be maintained. Table 1 shows the status of these five core documents.


